Debris, such as small limbs on roofs, that do not result in any further damage to the units or the units roof, are still to be addressed.

As much as the Board strives to be aware of maintenance issues, it is always possible to miss a need. The Board relies on the homeowners as Forest Oaks II is a self-managed homeowners association.

This includes, but is not limited to painting, lighting, doors/windows, satellite, awning, fence/gate, and patio covers. Requests are to be given to Linda Johnston.

Vehicle Parking and Safe Driving
