

## Board of Directors Meeting June 19, 2025 Minutes

### **DATE and TIME**

A regular meeting of the Board of Directors for the Forest Oaks II Homeowners Association was held on Thursday, June 19, 2025, at 5:30 p.m. at the Clubhouse.

#### CALL to ORDER-PRESIDING OFFICER

President JoAnna Medlen called the meeting to order at 5:42 p.m. Mike Craig and Judy Tabbert was present. JoAnna appointed Karen to act as secretary.

### **OUORUM**

A quorum was established with the following directors present:
JoAnna Medlen - President
Nancy Miller - Vice-president
Karen Stutzman - Director
Tonna Collins - Director

After establishing a quorum President JoAnna Medlen asked Vice President Nancy Miller to chair the meeting.

Nancy reminded all present of the rules of conduct during the meeting and that homeowners scheduled to address the Board had 5 minutes to speak. Nancy thanked all homeowners for coming out and attending the meeting.

### **MINUTES**

Motion by Tonna to accept the minutes, seconded by Karen, motion carried, unanimously approved.

### PRESIDENT'S REPORT

JoAnna thanked all homeowners for attending the meeting. JoAnna said a special Thank you to Linda Johnston for the time she gave to the association serving as a Board member. The lawn is looking really good and the lawncare contractor is doing everything that is in his contract. Homeowners were asked to give him a chance to take care of the neglect from the previous lawncare contractor instead of going around and taking pictures of everything they thought was not being done.

### **COMMITTEE REPORTS**

There were no committee reports.

### **FINANCIALS**

Judy Tabbert presented the April and May financials. Homeowners were reminded that the Board was making decisions based on balances in the column labeled "Excluding Accounts Receivable." Motion by Karen to approve financials, seconded by JoAnna, motion carried, unanimously approved.

### **OLD BUSINESS**

Nancy asked Judy to report on 25-26 insurance. Judy stated that insurance proposals had not been received from the associations agent. The Board will be notified when proposals are received. The current policy renewals on August 1. Motion by Tonna to call a special called meeting to review insurance proposals and select an insurance plan for 25-26, seconded by Karen, motion carried, unanimously approved.

Nancy asked Judy for an update on the special assessment. Judy reported that that payment had been received from 112 of 117 homeowners, 2 were to be paid from estates, and 3 were outstanding.

JoAnna stated Policy/Rules and regulations for potential new buyer needed to be tabled until attorney could do further research on the matter. Motion by Karen to table policy/rules and regulations until attorney let Board know he had something for Board consideration, seconded by JoAnna, motion carried, unanimously approved.

Motion by Tonna to approve the payment plan for Unit 916, seconded by Karen, motion carried, unanimously approved.

Motion by JoAnna to send all friendly and violation letters to Unit 916 by certified mail and the cost of the certified mail will be charged to the homeowner, seconded by Karen, motion carried, unanimously approved.

Motion by Tonna to approve payment for Unit 1112, seconded by Karen, motion carried, unanimously approved.

Move to Executive Session 6:17 returned at 7:40.

Motion by JoAnna to choose Option 3 of the financial break down on the Estate of David Keith Young, seconded by Karen, motion carried, unanimously approved.

Motion by Karen to allow the auction company auctioning Unit 1026 to have a dumpster for 14 days with an opportunity to extend the time frame and if any damage is caused due to the dumpster the auction will cover the cost of the damage, seconded by Tonna, motion carried, unanimously approved.

### **NEW BUSINESS**

Nancy opened nominations for Secretary/Treasurer by the Board. Tonna nominated Becky Avaritt. Nancy asked for other nominations. There were no additional nominations. Motion by Tonna to appoint Becky Avaritt to fill the remainder of Linda Johnston's term, which ends December 2025, seconded by Karen, motion carried, unanimously approved.

Pat Krogstad address the Board requesting that her daughter's dog, a Great Dane at Unit 1141, be grandfathered in under the February 2024 Pet Rules and Regulations. She stated that she had turned in the required paperwork at the time and that her daughter no longer wanted to pursue requesting the dog be considered as an emotional support animal and had decided to try this route.

Motion by Karen that the Great Dane is not grandfathered in under the February 2024 Pet Rules and Regulations, seconded by Toona, motion carried. JoAnna aye, Karen aye, Becky aye, and Tonna aye, Nancy abstain.

Motion by Karen that the Great Dane at Unit 1141 is to be removed from Forest Oaks II property by August 31, 2025 with a letter to be sent to homeowner notifying the homeowner, seconded by Tonna, motion carried, JoAnna aye, Karen aye, Becky aye, and Tonna aye, Nancy abstain.

Motion by Tonna to deny Mary Hargis's request to the Board to allow her daughter Katheen Zylar to reside at Unit 1126 in her absence, seconded by Karen, unanimously approved.

Motion by Tonna to approve the Architectural Modification Request Form Unit 1120 to replace the patio fence and Unit 908 to replace window, seconded by Karen, motion carried, JoAnna aye, Karen aye, Nancy aye, and Tonna aye, Becky abstain.

JoAnna provided an update on the trimming of trees and removals of trees. The HOA has not trimmed tree limbs near and off units since 2019. Proximity of trees and tree limbs are taken into consideration on insuring the association. The Ash trees infected by ash bores have diesdand need to be removed. Three pine trees have been identified as a threat to unit roofs and the needles from the trees are causing gutter problems and water damage to units. Motion by Karen to approve the quote of \$30,000.00 for the removal of the ash and pine trees and to trim tree limbs near or on units, seconded by Tonna, motion carried, unanimously approved.

Motion by Tonna to pay Procut to perform additional services outside of the lawncare contract, seconded by JoAnna, motion carried, unanimously approved.

Motion by Becky to reserve any decision on lawncare to the side of Unit 943 until the August meeting, seconded by Tonna, motion carried, unanimously approved.

Motion by JoAnna to proceed with turning over the delinquent account of Unit 1107 to the association attorney, seconded by Karen, motion carried, unanimously approved.

Motion by Tonna to pay association attorney \$275.00 per hour to attend the Forest Oaks II Board of Directors meetings retroactive to January 1, 2025, seconded by Becky, motion carried, motion unanimously approved.
